May	<ul style="list-style-type: none"> - Students with completed files may begin viewing their awards online for the upcoming Fall semester. - Students may continue to apply for aid by completing the FAFSA [after this month however, aid may not be processed before the Fall payment is due. - Spring semester ends. - Satisfactory Academic Progress is evaluated for Summer/Fall/Spring eligibility - Fall financial aid awards are available for viewing online. - Summer Financial Aid Awards are available for review online.
June	<ul style="list-style-type: none"> - Summer classes begin. - New SUBR students must complete the online loan entrance counseling at www.studentloans.gov. - Summer Aid disbursed to students accounts - New Freshmen Orientation Sessions begin for Fall term - Book Voucher Process begins for Summer term
July	<ul style="list-style-type: none"> - End of the 60% period for the Return of Title IV Aid. - Registration for Fall. - New Freshmen Orientation Sessions On-going for Fall term
August	<ul style="list-style-type: none"> - Federal Direct Loan borrowers must complete an Online Loan Entrance Counseling at www.studentloans.gov. - Fall orientation sessions Fall classes begin. - On-Site Fall Registration Activities begin - Fall Book Voucher Process begins
