SUBR ACM Student Chapter Officers.

The officers of the SUBR ACM student chapter are Chairman, Vice-Chairman, Secretary, and Treasurer. The officers must be

- full-time students of Southern University and A & M College,
- national members of the ACM, and
- members of the SUBR ACM student chapter.

Duties of Officers.

The **Chairman** shall

- preside at all meetings of the SUBR ACM student chapter (this Chapter) and of its Executive Council;
- represent this Chapter at all meetings; and
- appoint all committees of this Chapter and Chairman, except the Chairman of the Program Committee.

The **Vice-Chairman** shall

- assume the duties of the Chairman in the event of the Chairman's absence;
- assume the duties of the Chairman that are delegated to the Vice-Chairman by the Chairman; and
- act as the Chairman of the Program Committee.

The **Secretary** shall

- keep minutes of all Chapter meetings and Executive Council meetings;
- prepare the Annual Chapter Report for presentation to the Chapter at the Election Meeting and present the report to the Chairman of the ACM Committee of Membership after each meeting;
- send official notifications to the Chairman of the ACM Committee of Membership of changes in the elected officers or Faculty Advisor of the Chapter; and
- send official notification to the Executive Director of the SCM of any changes in the chapter's bylaws for approval prior to distribution to the membership and notify the Executive Director promptly of the final action of proposed changes.

The **Treasurer** shall

- collect dues and maintain financial and membership records; and
- prepare the annual report of the Chapter's finances required by the Treasurer of the ACM.
