Scholarship Eligibility Requirements

Your success at Southern University and Agricultural & Mechanical College is our primary concern. The 20 for 20 Scholarship fund was established to support students with unmet financial needs. The eligibility requirements are as follows:

- Must be enrolled in an undergraduate or graduate program as a full-time student at Southern University, Baton Rouge Campus at the time of application.
- Must have declared a major as documented by their Academic Advisor at the time of application for the scholarship.
- Applicants must demonstrate academic promise and have earned a cumulative grade point average of 2.5 or above for undergraduates and 3.3 cumulative grade point average or above for graduates in all coursework completed at the time of application.
- Applicants must complete and submit essay that identifies why they selected Southern University, academic or co-curricular opportunities in which they have engaged in as a student, an outline of their academic and career goal, and how the scholarship will help the applicant meet their goals.
- Applicants must demonstrate financial need for the scholarship as determined by the Office of Financial Aid.
- Applications for this scholarship must be completed in its entirety using the appropriate form. The application must be submitted to the Office of the Vice Chancellor for Student Affairs & Enrollment Management by May 31, 2018. Applications containing information that is determined to be false or inaccurate and are incomplete will not be considered.
- Students may receive the award only once an academic year during their undergraduate or graduate career at Southern University and Agricultural & Mechanical College. The award is applied and valid in the semester outlined in this application.

PLEASE SUBMIT APPLICATIONS BY MAY 31, 2018

Applications must be received in the Office of the Vice Chancellor for Student Affairs & Enrollment Management by the specified deadline. Applications may be hand delivered to Suite 213, 2nd Floor, Smith-Brown Memorial Student Union or via Regular First Class Mail to P. O. Box 13405, Baton Rouge, LA 70813. These scholarships will be awarded as funds are available.
