The main function and purpose of student teaching experiences is to help the student teacher: (1) achieve success in teaching-learning situations, and (2) achieve adequate control of teaching-learning conditions.

Teacher candidates are required to complete a minimum of 270 clock hours in student teaching with at least 180 of such hours spent in actual teaching. A substantial portion of the 180 hours of actual teaching is on an all-day basis.

Teacher candidates consistently rank the clinical experience among the most valuable components of their preparation. It is indeed the culmination of the teacher preparation program, the time to "put it all together," to learn in the real world of the schools.

Describe your institution's most successful strategies in meeting the assurances listed above:

Teacher candidates must complete 180 hours of field experiences prior to entering student teaching or internships. These are very structured experiences that are cooperatively orchestrated between the school supervisors and college supervisors. Candidates must complete key assessments related to field experiences using the electronic data collection system that is used by the University. The centerpiece of the system is the electronic portfolio that must be completed by all candidates by the end of the program. The teacher work sample is included in this portfolio, that is used by candidates to collect data on student learning while performing field experiences in schools. Candidates in the Certification-Only year-long internship program utilize their classrooms to perform action research and to assess student learning gains using teacher work samples.

Technology is integrated throughout the Alternate Certification Program. Teacher candidates must complete an electronic teacher work sample that require candidates to collect, manage, and analyze data in order to improve teaching and learning for the purpose of increasing student academic achievement. Coursework in this program allows candidates to utilize a variety of teaching and learning styles to ensure that all children learn the knowledge and skills necessary to be successful in schools.

The College of Education utilizes an electronic data collection system, LiveText, to collect data on key assessments that are embedded in each content and professional course. The electronic portfolio is the centerpiece of this system. Candidates begin building the portfolio upon entrance in the program and are expected to have completed the portfolio during the student teaching or internship phase of the program. Candidates collect data on student learning gains using teacher work samples that are included in the portfolio. Data are collected and analyzed to assess methods of teaching and learning. The electronic portfolio becomes an electronic vitae as candidates search for jobs.

The major aim of the integrated to merged programs with emphasis in special education is to develop teachers with core experiences designed to foster comprehensive knowledge of human learning and the practical application of this knowledge to the remediation and management of learning difficulties relative to exceptional children and youth. Teacher candidates are provided opportunities through at least 12 hours of course work and a minimum of 180 hours of field experiences to observe and participate in classrooms with special needs students. Teacher candidates are afforded opportunities to work with at-promise schools in low-income areas. Secondary education majors take at least 3 hours in special education and are provided structured and monitored experiences in working with exceptional children in diverse situations.
