Southern University and A&M College has approximately 6,500 students and is a public historically black university. Located in Baton Rouge, Louisiana, the institution is the flagship campus of the Southern University System, offering programs at the baccalaureate, master's, professional and doctoral levels.

Vice Chancellor for Student Affairs & Enrollment Management July 2014 Present

The Vice Chancellor for Student Affairs & Enrollment Management is responsible to the Chancellor for providing visionary leadership and strategic direction to the enrollment and student affairs divisions for graduates and undergraduates in support of the academic mission of the University. The Vice Chancellor manages a budget in excess of \$25 million and supervises approximately 300 staff, including administrative professionals, directors, classified staff, and student workers in the areas of Admissions & Recruitment, Campus Dining, Career Services, Center for Student Success, Center for Teaching & Learning Excellence, Financial Aid, Horace W. Moody, Sr. Intramural & Recreational Sports Complex, the "Human Jukebox" Marching Band, Student Orientation & Leadership Development, Residence Life & Housing, Smith Brown Memorial Union, Student Health Center, Student Life, Student Programs & Greek Life, Student Media, Student Organizations, University Counseling Center and University Events. The Vice Chancellor works collaboratively to support related service missions, such as TRiO Student Support Services, enrollment management, orientation, recruitment and retention. The Vice Chancellor also plans, develops, manages, and administers programs and strategies for enrollment management and student affairs that support the University's strategic plan and mission and collaborates with academic and campus leadership to develop and implement a comprehensive strategic plan to recruit, retain, and serve a vibrant and diverse student body. The Vice Chancellor chairs the Enrollment Management Council and develops a comprehensive enrollment management plan that complements both Southern University's strategic goals and the Southern University System's strategic priorities, in collaboration with Academic Affairs, to coordinate and facilitate a cross divisional, cooperative, and integrated approach to recruitment, admissions, enrollment, persistence, and degree completion across all academic colleges and programs.

Selected Accomplishments:

- Increased first-time freshman enrollment by 30% (1,210 students) reversing negative institutional enrollment trend.
- Created and Implemented the "Pathway to Prominence" Recruitment Tour which has resulted in an increase of undegraduate admission applications to the University by 83% to date.
- Created the Student Affairs & Enrollment Management Assessment Committee, which
 positions the Division to meet SACS accreditation requirements and monitor student learning
 outcomes.
- Relocated the offices within the Division to create a "One Stop Shop" which enhanced student satisfaction with the services received from the Enrollment Management units.
- Decentralized the University Registration process, which resulted in the elimination of lines increasing student, staff, and parent satisfaction with the registration process.
- Maintained International Association of Counseling Services, Inc. accreditation of the University Counseling Center.
- Introduced the "Go Green" initiative in conjunction with the University Bookstore to introduce academic regalia made from 100% post-consumer recycled plastic bottles.
- Repurposed over \$700k of student self-assessed fees to support scholarships, transit enhancements, and campus beautification initiatives in conjunction with the Student Government Association.
- Led the process and implemented the overall reorganization of the Division of Student Affairs to increase efficiency and effectiveness in student satisfaction.
- Secured funding for the Student Affairs Scholarship, which has awarded in excess of \$150k in scholarships to academically eligible students.
- Opened the newly constructed, 32,000 square feet, Intramural & Recreational Sports Complex (\$6.1 million).
- Completed the expansion of and exterior upgrades to the Student Health Center (\$680k).
- Completed interior and exterior upgrades to the Smith-Brown Memorial Student Union (\$300k).
- Renovated occupied and reopened several residential housing facilities that were previously closed to accommodate a rapidly increasing on-campus student population (\$650k).
- Completed the construction of the outdoor Intramural Basketball Courts (\$76k).
- Revamped the Student Code of Conduct to reflect best practices identified by the Association for Student Conduct Administration.
- Increased the grade point average required for initiation into Greek Letter Organizations.

The Vice Chancellor for Student Affairs was the Chief Student Affairs Officer for Southern University and A&M College and manages a budget in excess of \$20 million. Reporting to the Chancellor, the Vice Chancellor served as the chief advisor to the campus administration on all student related matters and provided executive leadership and direction in ensuring the overall development of each student as an individual in the context of the university community through collegial leadership, vision, creativity and dedication. As Chief Student Affairs Officer, the Vice Chancellor provided leadership and accountability for the administration, development, assessment and improvement of student services and experiences which meet and support the University's mission and strategic plan. The Vice Chancellor was responsible for enhancing the learning environment through students, educational support services and activities, and experiences gained outside of the classroom. In addition, the Vice Chancellor coordinated legal issues relating to student higher education issues; campus communication and collaboration with internal constituencies such as faculty, staff and other administrative colleagues; and budget development, planning and assessment. Reporting to the Vice Chancellor for Student Affairs & Chief Student Affairs Officer were the directors for: Campus Dining, Career Services, Intramural & Recreational Sports, New & Transfer Student Orientation, Residence Life & Housing, Smith Brown Memorial Union, Student Health Center, Student Life, Student Programs & Greek Life, Student Media, Student Organizations and the University Counseling Center. Finally, the Vice Chancellor served as the student advocate within the University community. Reporting to the Provost, the Associate Vice Chancellor for Student Affairs & Chief Student Affairs Officer possessed the same authority, duties and responsibilities prior the position being elevated to a Vice Chancellorship.

Selected Accomplishments:

- Created the Student Affairs Advisory Council, comprised of representatives from all University
 constituencies, for advisement relative to modifying and enabncing overall divisional
 operations to improve student satisfaction.
- Launched the "Leave Your Mark on SU" Donor Brick Program to create additional revenue streams to support divisional initiatives.
- Led the Division of Student Affairs to become fiscally independent from the University's general fund budget (state appropraitons) through the utiliation of strategic budgeting and targeted resource allocation.
- Working with the leadership of the Student Government Association, revised student selfassessed fees to maximize the impact, benefit, and to address the needs of the entire student population.
- Significantly increased the financial and administrative resources available to Registered Student Clubs and Organizations through the establishment of the Office of Student Organizations.
- Increased divisional partnerships with community offices and businesses such as the Exxon-Mobil YMCA and the Office of the Mayor-President of East Baton Rouge Parish.
- Inititated and Chaired the Inaugural Registration Task Force that coordinated the first seamless studenet registration process in decades in August, 2012.
- Began the process of modernizing the Smith-Brown Memorial Student Union through capital improvements and interior renovations.

SOUTHERN UNIVERSITY SYSTEM

Created by the Louisiana State Constitution in 1974, the Southern University System is the Nation's only Historically Black College and University System. The University System enrolls approximately 15,000 students at it member campuses – Southern University and A&M College, Southern University at New Orleans, Southern University at Shreveport, Southern University Law Center, and the Southern University Agricultural Research and Extension Center.

Deputy Chief of Staff Office of the President

As Deputy Chief of Staff, assisted the Chief of Staff in overseeing the day to day management and operational functions of the Office of the President. The Deputy Chief of Staff served as a key member of the President's staff assisting with the central coordination of activities (operations and planning) and ensuring timely flow of information to and from the executive office. Tracked, monitored and followed the progress of projects, action items, and strategies that emanated from the President's cabinet, Board of Supervisors, etc. Served as liaison between the Office of the President and internal/external constituencies. Regularly required to resolve complex administration problems and independently performed diverse and advanced tasks. Also, worked effectively with the Chief of Staff to handle confidential, controversial and sensitive issues matters relative but not limited to university finances, employee salaries, personnel issues, and policy changes with extreme tact, maturity, discretion, decorum, and the highest level of confidentiality. Performed duties as assigned or delegated to meet the needs of all constituents of the Southern University and A&M College System.

Executive Associate to the President Office of the President

July 2009 - June 2010

The Executive Associate to the President relieved the President of operational and administrative details and performed administrative functions that required a thorough knowledge of University policies, procedures, and operations and an understanding of the University's role within the community. The Executive Associate to the President exercised initiative and independent judgment in managing the President's schedule and the office's daily activities. Serving as the President's liaison, the Executive Associate to the President had frequent and recurring contact with other University administrators, members of the Board of Supervisors, public and private officials, various boards, faculty, staff, students, parents, and the various publics served by the University by communicating and/or interpreting policy, decisions, and documents issued by University, gathering information and providing information to the President, and representing the President's Office on select University and civic committees. Assists the President in oversight functions by reviewing, monitoring, and approving University personnel action forms and reviewing correspondence and documents prepared by other offices for the president's signature. Assisted with development and management of the budgets under control of the President's Office by maintaining budget records, producing financial reports and summaries, approving expenditures, and completing budget transfers. Promoted a positive image of the University by greeting and receiving visitors to the President's Office, providing authoritative information regarding University policies or decisions, referring inquiries or problems to the appropriate office or person, resolving problems, and following up to determine the inquirer's satisfaction with the response. The Executive Associate contributed to the overall success of the University by performing other essential duties and responsibilities as assigned.

Executive Director for Student Affairs & Special Assistant to the Vice President Office of the Vice President for Academic & Student Affairs

September 2008 – June 2010

The Executive Director for Student Affairs, reported to the System Vice President for Academic & Student Affairs was charged with the coordination of student activities, leadership development, engagement priorities and selected research projects based on the mission, vision and values of the Southern University and A&M College System and its member campuses. As the primary student officer of the Southern University and A&M College System, the Executive Director was responsible for providing leadership through a team approach to delivering comprehensive student support services

and enhancing institutional collaboration for teaching and learning. The comprehensive support services included: Career Services, Dining Services, Student Health, University Counseling Center, Intramural Sports, Residential Life, Student Union, Student Life, Student Media, and Student Programs on the various campuses. The Coordinator also provided the administration with information that enhanced strategic planning, decision making and institutional performance measures relative to students. The Executive Director also worked collaboratively with internal and external constituents on a wide range of topics at the direction of the System Vice President for Academic & Student Affairs. The Executive Director was ultimately responsible for the coordination and management of all student related issues within the University System at each of its member campuses. Additionally, the Special Assistant was responsible for assisting the Vice President to development, implement, and monitor academic policies and procedures at the system and campus level.

Executive Assistant to the Director Office of the Internal Auditor

July 2007 - August 2008

The Executive Assistant to the Director provided executive administrative support to the Director of Internal Audit and was her primary point of contact and a liaison for the Office of the Internal Auditor and handled complex situations with multiple responsibilities. The Executive Assistant had regular contact and interaction with high level internal and external constituents, which required discretion and confidentiality. The primary duties and responsibilities involved the oversight of office operations and supporting the Director to fulfill her responsibilities to the Board of Supervisors. Typical responsibilities included coordinating schedule; arranging training sessions, meetings and events; assisting in budget preparation; arranging travel and assisting students, staff, and the public; and, representing the Office of the Internal Auditor on committees and at meetings. The Executive Assistant was distinguished from other executive support positions by their responsibility for providing high level support to the Director of Internal Audit. Assignments required a high degree of confidentiality and involved interactions with multiple levels of staff and contacts within the University System.
