#### **Guidelines and Eligibility Requirements for Scholarships**

- Applicants for must be enrolled undergraduate, full-time students at Southern University and A&M College at the time of application.
- Available only to incoming freshmen enrolling for the Fall 2017 semester.
- We will offer five (5) \$1,000 scholarships that can only be used for tuition, books, and on-campus room and board. The scholarship cannot place students in refund status.
- Applicants must demonstrate academic promise and have earned an overall high school cumulative GPA of 2.0 (on a 4.0 scale).
- Applicants must complete and submit a 250-word statement on their goals, experiences and how
  the scholarship will help the applicant meet further goals.
- Applicant must major in a business related field.
- Applicants must prove financial need for the scholarship as determined by the Office of the Dean of Students and/or the Office of Student Financial Aid.
- Applications for this scholarship must be completed using the appropriate form and submitted to the Office of the Dean of Students by the specified date mentioned below with all required information.
- The application must be completed in its entirety. Applications containing information that is determined to be false or inaccurate and are incomplete will not be considered.
